Rules & Regulations

- Discipline and obedience are the dual keynotes to success. We expect our students to maintain the same all the time.
- Attendance in the class should be regular. Late-comers for 10 minutes or more will not be allowed to attend the particular lecture.
- Homework assigned must be tried sincerely.
- If a student misses a particular lecture, then he/she must make-up for the portion and homework before attending the next lecture and a leave note signed by the parent must be presented to the teacher.
- Attendance in all tests is compulsory. The parents, in writing, must intimate absence from any of these tests for reasons beyond any control. This needs to be done before the start of the examination.
- No re-examination will be conducted for the absent students. The 'ABSENT' remark on the mark sheet is equivalent to zero in the examination. As a result, the student may suffer in the ranking list of the classes.
- All students are expected to respect the sanctity of the examination environment and conduct themselves in the appropriate manner. Misbehaviour of any kind can lead to expulsion of the student from the classes without any refund of fees.
- Writing on benches, walls and toilets is strictly prohibited. Any student found indulging in such activities in the class premises or the Examination Venue will be strictly punished or even expelled from the classes, without any refund of fees.
- Students are not to touch any of the electrical switches or air-conditioners or water coolers etc. Any student found damaging property of the classes or Exam Venue, shall have to replace the article or pay for the replacement.
- Use of mobile phones or any other electronic gadgets within the class premises is strictly prohibited. Make sure that mobile phones and other devices are in OFF mode before the student enters the class. Any student found using mobiles and or other gadget inside the classrooms, corridors or during lectures shall be strictly dealt with.
- The management reserves the right to change or modify the rules, change the time of the classes, consolidate class without giving any reason whatsoever. Management's decision will be final and binding on all students.
- If Service Tax rate is increased subsequently, then the student will have to pay the difference amount.
- Management doesn't hold any responsibility for any kind of loss of personal belongings in the classroom premises.
- Management doesn't hold any responsibility for any kind of injury to any student in the classroom premises.
- Fees once paid will not be refunded under any circumstances. Also it will not be adjusted towards any other student or towards any subsequent year.
